Pedestrian crossing signal equipment would also be installed at the southernmost intersection of Main Street and Route 17. A new section of 5-foot-wide sidewalk would be installed along the frontage of the Fox Mill Centre shopping center, over a distance of 0.18 miles, to close a gap in the existing sidewalk network on Route 17.
